#### **Entrance Examination for Graduate Course: Academic Year 2023**

In the Department of Agricultural and Resource Economics, entrance examination for graduate courses will be changed from face-to-face format to online. For detail, you will check the official application guidelines which will be released on early April at the Homepage of Graduate School of Agricultural and Life Sciences, The University of Tokyo. Official application guidelines are written ONLY in Japanese. English versions are not available. Those who are not able to understand Japanese, please consult your prospective professor. ## **English**

TOEFL(TOEFL-iBT or TOEFL-iBT Home Edition) score must be submitted before the designated date. We DO NOT accept the score received after the deadline for any reasons. Test scores you took in <u>August 2020</u> [Correction: Original description was January 2021] or later is valid.

## Special subjects

Select three subjects from the below lists at the time of application: Farm Management, Economics, Agricultural Economics, Agricultural Policy, Agricultural History, Rural Development.

After the application deadline, essay assignment for each special subject will be sent. Write essays regarding assignments and submit them before the designated date. Essay assignment will be given both in Japanese and English.

#### Oral examination

Oral examination will be conducted online. Five minutes presentation for research proposal is required for businessperson who applies to selective examination.

### Number of students to be admitted

Maximum of 17 persons will be admitted. Note that the pre-selection might be conducted depending on the number of applicants.

### **Application document to be submitted**

For general selective examination, statement of the reason to apply for admission (within 1000 words, A4 paper) must be submitted as well as Application form, Transcription of academic record, and Certificate of graduate or Diploma. Applicants for special selective examination must submit research proposal instead of the statement of the reason to apply for admission.

#### Remark

Applicants for special selective for business person are strongly recommended to discuss the research proposal with the prospective professor and confirm the possibility to acceptance before the application. **Doctoral Course** (General and Special selective for business person)

## **English**

TOEFL(TOEFL-iBT or TOEFL-iBT Home Edition) score must be submitted before the designated date. We DO NOT accept the score received after the deadline for any reasons. Test scores you took in <u>February 2021</u> [Correction: Original description was January 2021] or later is valid.

# Special subjects

Select three subjects from the below lists at the time of application: Farm Management, Economics, Agricultural Economics, Agricultural Policy, Agricultural History, Rural Development.

After the application deadline, essay assignment for each special subject will be sent. Write essays regarding assignments and submit them before the designated date. Essay assignment will be given both in Japanese and English.

#### Oral examination

Oral examination will be conducted online. Five minutes presentation of master's thesis is required for general selective applicant. Ten minutes presentation of submitted paper and research proposal is required for businessperson who applies to selective examination.

### Number of students to be admitted

Maximum of 8 persons will be admitted.

# Application document to be submitted

For general selective examination, master's thesis, or the papers as a substitute of master's thesis must be submitted as well as application form, transcription of academic record, and certificate of graduate or diploma. If the master's thesis is written in other languages than Japanese or English, English translation must be accompanied. Applicants of special selective examination for business person must submit research proposal in addition to the above documents.

#### Remark

Applicants for doctoral program are strongly recommended to discuss the research proposal with the prospective professor and confirm the possibility to acceptance before the application.
