Answer the questions of the three subjects you registered in the application out of the following subjects.

1. Farm Management

Explain the current situation in which various business forms exist in farm business and discuss the factors that influence the choice of business form. Answers should be 3-4 pages on A4 paper including the list of references.

2. Economics

Answer the following questions within three pages including the list of references.

- (1) Explain the theory of monopolistic competition.
- (2) Give some examples of monopolistic competitive markets observed in your country, and explain *one* of them according to the theory you explained the above problem.

3. Agricultural Economics

Discuss the issues that should be addressed in current food policy from the perspective of human health, global environment, and ecosystem. You should write your answer within 2 sheets of A4 size paper. The number of the referred/ cited papers and materials should be no more than three. The list of referred/ cited papers and materials should be written at the end of the document within the prescribed pages.

4. Agricultural Policy

First, explain what food security is. Next, briefly explain the situation of agricultural production and agricultural structure in your country, and then discuss the food security policy of your country. Answers should be 2-4 pages long including the list of references.

5. Rural Development

Consider staple food crop production, for example maize production, by smallholders in a developing country, where net sellers, net buyers, and pure subsistence farmers coexist. If we calculate the profit from maize production using a standard formula given below, many farmers will have a negative profit and sometimes even their average profit will be less than zero.

$$Profit = pY - M - w(H + L) - Q - R$$

where Y = maize production (kg), p = maize price observed in the market after the harvest (\$/kg), M = cost of purchased inputs such as fertilizer, herbicide, insecticide, etc. (\$), H = total amount of hired labor (man-days), L = total amount of family labor (man-days), W = daily wage rate (\$/man-day), Q = cost of machines, either animal traction or tractors (\$), and Q = cost of land (\$). Then, answer the following questions.

- (1) The formula above assumes that wage rate for family labor is the same as for hired labor. In what conditions will such an assumption be justifiable? Is it generally justifiable in rural areas in developing countries?
- (2) If a household uses its own machines, how will the cost for it (Q) be evaluated to calculate the profit?
- (3) If a household uses its own land, how will the cost for it (R) be evaluated to calculate the profit?
- (4) It is natural that an unexpected negative production shock and/or an unexpected negative price shock can reduce the profit even to below zero. However, other than such natural cases, there should be cases where the calculated profit is lower than farmers actually think. Discuss why such discrepancies happen with smallholders in developing countries.

Note that the maximum volume of the answer is 3 pages excluding the list of references.

6. Development Economics

What does "spatial market integration" mean? In the case of agricultural product market in developing countries, what kinds of problems happen in poorly integrated markets compared with well integrated ones? Discuss potential impacts of digital technologies on the integration of agricultural product markets in developing countries. Note that the maximum volume of the answer is 3 pages excluding the list of references.

3. 農業経済学 Agricultural Economics

2021年9月23日~24日に開催された国連食料システムサミットで議論された内容を紹介しながら、今後の食料政策への示唆を論じなさい。A4用紙で2枚以内に日本語または英語でまとめなさい。関連する文献や資料を参照・引用することも可能である。参照・引用する文献・資料は合計で3点以内とすること。参照・引用文献は文章末に明示し、それも含めて規定の枚数に収めること。

Introduce what was discussed at the UN Food Systems Summit, held from 23 to 24 September, 2021, and discuss the implications for future food policy. You should write your answer within 2 sheets of A4 size paper in Japanese or English. The number of the referred/cited papers and materials should be no more than three. The list of referred/cited papers and materials should be written at the end of the document within the prescribed pages.

4. Rural Development

It is known that farmers in developing countries depend on varieties of informal insurance mechanisms in order to smooth consumption in the risky environment.

- (1) Explain why formal insurance is still necessary in spite of the informal arrangements in developing countries.
- (2) Explain why formal insurance such as crop insurance is generally infeasible in developing countries.

Index insurance is considered to solve the problems with conventional crop insurance.

- (3) What is index insurance? What are its advantages over conventional crop insurance?
- (4) Is there any weakness in index insurance? If yes, explain.
- (5) Discuss the impact of index insurance on agricultural production in developing countries based on several empirical studies.

Note that the maximum volume of the answer is 3 pages excluding the list of references.
